# HARMFUL MATERIALS THAT ARE PROHIBITED IN COSMETICS

#### Hydroquinone

- Skin redness, discomfort
- Hypersensitivity toward skin
- Inhibits the pigmentation process
- · Reduces skin protection from UV rays
- Risk of skin cancer

#### **Tretinoin**

- Stinging, peeling
- Increase skin sensitivity to sunlight
- Skin discomfort

#### Mercury

- Damage to the kidneys and nervous system
- Skin rashes and inflammation
- Interfere with the development of the brain in unborn children and very young children
