## What Pinetarsol Solution is used for

- An adjunct treatment to help relieve itchy and inflamed skin
- To relieve the symptoms of dermatitis (inflammation of the outer layer of the skin), chicken pox, nappy rash, sunburn, prickly heat, hives, insect bites, anal and genital itching and other skin irritations
- To relieve the symptoms of psoriasis (auto-immune inflammatory skin disorder)

## How Pinetarsol Solution works

- Soap free cleansing solution with pine tar to relieve severe itching and reduce inflammation
- A soap alternative as soap may irritate tender and inflamed skin.

## Before you use Pinetarsol Solution

### - When you must not use it

This product should not be used by individuals with known sensitivity to any ingredients of this product.

### - Before you start to use it

Please discuss with your doctor or pharmacist before using the product.

### - Taking other medicines

Currently there have been no reports of problems when this product is used with other medicines.

## How to use Pinetarsol Solution

### - How much to use

For very inflamed skin, use with water. Shake bottle before use. Bath: Add 15-30 mL\* to a warm to tepid bath (5 mL\* to baby's or hand basin).

\*One capful contains 5 mL.

Shower: Apply directly to wet skin, leave a few minutes, briefly rinse. Pat skin dry.

For small areas/patients in bed: Add 10mL to 3 L of water, sponge, pat skin dry.

### - When to use it

Bathe for 5-10 minutes once daily, more often in severe cases.

### - How long to use it

Please follow the advice of the doctor or pharmacist.

### - If you forget to use it

If forget to use this medicine, use it as soon as remember. Then next, use this medicine at the usual time.

### - If you use too much (overdose)

No information is available concerning overdosage in human beings following topical application.

## While you are using it

### - Things you must do

Avoid contact with eyes. For external use only.

### - Things you must not do

Do not swallow.

### - Things to be careful of

If any irritation occurs, discontinue use.

## Side effects

There are no known side effects for pine tar when used topically. Allergy to any ingredient may cause skin irritation.

## Storage and Disposal of Pinetarsol Solution

### - Storage

Store below 30°C. Keep out of reach of children.

### - Disposal

Pinetarsol Solution should not be disposed of via wastewater or household waste. Ask your pharmacist how to dispose of Pinetarsol Solution that is no longer required. These measures will help to protect the environment.

### - What it looks like

Pinetarsol Solution is dark green liquid with a smell characteristic of pine tar. Available in 200mL & 500mL bottles.

- Active ingredients: pine tar, triethanolamine lauryl sulphate.
- Inactive ingredients: purified water, lavender oil, CI food brown 3, phenethyl alcohol, fluorescein sodium.
