What Prime B-forte is used for

It is used as a supplement of vitamin B complex.

How Prime B-forte works

Prime B-forte are involved in various metabolism of the body. They are essential for the normal functioning of various organs in the body.

Before you use Prime B-forte

- When you must not use it

Do not take Prime B-forte if allergic to any ingredients in the tablets.

- Before you start to use it

Tell your doctor if you have any medical conditions.

- Taking other medicines

Tell your doctor if you are taking any other medicines, including any that you buy without a prescription from a pharmacy, supermarket or health food shop.

How to use Prime B-forte

- How much to use

1 tablet 3 times daily. Follow all directions given by your doctor and pharmacist carefully. They may differ from the information contained in this leaflet. If you do not understand the instructions on the label, ask your doctor or pharmacist for help.

- When to use it

Use as directed by your doctor or pharmacist.

- How long to use it

Continue taking Prime B-forte for as long as your doctor recommends.

- If you forget to use it

Consult your doctor or pharmacist on what you should do if you forget to use it. Take the missed dose as soon as you remember. If it is almost time for your next dose, wait until then to take the medicine and skip the missed dose. Do not take a double dose to make up for the missed dose.

- If you use too much (overdose)

Contact your doctor immediately or go to the Emergency Department of your nearest hospital, if you think you or anyone else may have taken too much of this medicine. Do this even if there are no signs of discomfort or poisoning. You may need urgent medical attention.

While you are using Prime B-forte

- Things you must do

Take your medicine exactly as your doctor has told you. Tell all the doctors, dentists and pharmacists treating you that you are taking Prime B-forte. Tell your doctor immediately if you are pregnant while taking this medicine.

- Things you must not do

Do not stop taking the medicine unless advised by your doctor. Do not take any new medicines without consulting your doctor. Do not give Prime B-forte to anyone else, even if they have the same symptoms or condition as you.

- Things to be careful of

Large doses are not recommended without doctor's advice..

Side effects

Vitamin B complex are water soluble and do not cause toxic effects in persons with normal renal functions. However, visit your doctor or pharmacist immediately if you experience any side effects after taking this medicine.

Storage and Disposal of Prime B-forte

- Storage

Store in cool, dry place below 25°C. Protect from light. Keep out of reach of children.

- Disposal

Medicines should not be disposed of via wastewater or household waste. Ask your pharmacist how to dispose of medicines no longer required.

Orange, round biconvex tablet.

- Ingredients

- Active ingredient: thiamine mononitrate, riboflavin, nicotinamide, pyridoxine hydrochloride, cyanocobalamin, calcium pantothenate and folic acid
- Inactive ingredients: lactose monohydrate, cornstarch, polyvinylpyrrolidone, aerosil 200, magnesium stearate, dried cornstarch, methocel E-15, talc, titanium dioxide quinoline yellow lake, sunset yellow lake, carbowax 6000, simethicone 70460 and deionised water
