What PVP Iodine Solution is used for

Indicated as disinfectant & antiseptic for the treatment of contaminated wounds, cuts and burns and also for the pre-operative preparation of the skin and mucous membrane.

How PVP Iodine Solution works

Works by preventing the growth of disease causing microbes and to destroy bacteria.

Before you use PVP Iodine Solution

- When you must not use it

Pregnancy and lactation

No reports regarding adverse effects.

Ask your doctor or pharmacists for advice before taking PVP Iodine Solution.

- Before you start to use it

Tell your doctor if you undergo thyroid function tests or allergic to povidone iodine or other ingredients of this product.

- Taking other medicines

Tell your doctor if you are taking any other medicines, including any that you buy without a prescription from a pharmacy, supermarket or health food shop.

How to use PVP Iodine Solution

- How much to use

Clean the affected areas and apply the solution with cotton wool lightly and thoroughly.

The directions given may differ from the information contained in this leaflet. If you do not understand the

instructions on the label, ask your doctor or pharmacist for help.

- When to use it

Use as directed by your doctor or pharmacist.

- How long to use it

Continue taking PVP Iodine Solution for as long as your doctor recommends.

- If you forget to use it

Take the missed dose as soon as you remember. If it almost time for your next dose, wait until then to take the medicine and skip the missed dose. Do not take a double dose to make up for the missed dose.

- If you use too much (overdose)

Excessive absorption may occur due to application to large areas of broken skin or burns. Symptoms of overdose may include

- Metallic taste
- Increase salivation
- Burning or pain and inflammation of the mucous membrane in the nose
- There may be swelling and inflammation of the throat.
- Eyes may be irritated and swollen
- Fluid accumulation in the lungs may develop
- Skin reactions include acne or severe eruptions.
- Gastro-intestinal upsets and diarrhea also reported.

Contact your doctor immediately or go to the Emergency Department of your nearest hospital, if you think you or anyone else may have taken too much of this medicine. Do this even if there are no signs of discomfort or poisoning. You may need urgent medical attention.

While you are using it

- Things you must do

Take your medicine exactly as your doctor has told you.

Tell the doctor, dentist and pharmacist treating you that you are taking PVP Iodine Solution.

- Things you must not do

Do not take any new medicines without consulting your doctor or pharmacist.

Do not give PVP Iodine Solution to anyone else, even if they have the same symptoms or condition as you.

- Things to be careful of

Caution should be exercised in the prolonged use of Providone-Iodine in neonates.

When applied externally, skin should not be covered with occlusive dressing.

Side effects

Side effects of the PVP Iodine Solution considered to be less irritant than Iodine.

Visit your doctor or pharmacist immediately if you experience any side effects after taking this medicine. Storage and Disposal of PVP Iodine Solution

- Storage

Keep out of reach of children
Protect from light
Store in dry place below 30°C
Keep the container tightly closed
For external use only

- Disposal

Medicines should not be disposed of via wastewater or household waste. Ask your pharmacist how to dispose of medicines no longer required. These measures will help to protect the environment.
