## Hydroquinone

- Kemerahan dan ketidakselesaan pada kulit
- Kulit menjadi hipersensitif

## Tretinoin

- Kulit pedih dan mengelupas
- Hipersensitif kepada matahari
- Kulit tidak selesa

## Merkuri

- Kerosakan buah pinggang dan sistem saraf
- Ruam kulit dan inflamasi
- Mengganggu perkembangan otak kanak-kanak

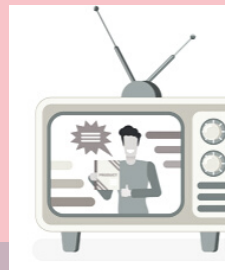

## SENTIASA PEKA DAN BERWASPADA DENGAN IKLAN PRODUK



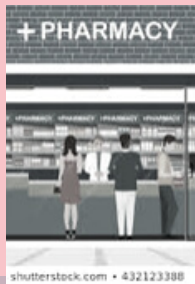
Jangan mudah terpedaya dengan iklan yang mampu mengubah paras rupa dalam tempoh yang singkat

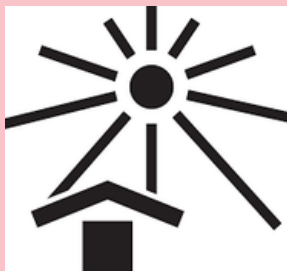
