What Duzen is used for

It is used to treat conditions where the skin is infected by germs, e.g. impetigo(weeping, crusty and swollen patch of skin), boils or infected wounds.

How Duzen works

It contains sodium fusidate which is an antibiotic that kills the susceptible germs that cause infections.

Before you use Duzen

When you must not use it - allergic to *Duzen* or other ingredients of *Duzen*.

Before you start to use it Caution when using near the eyes as it may cause irritation. Inform the doctor if pregnant or lactating.

Taking other medicines
Please inform the doctor or
pharmacist if taking other
medicines. The medicine usually
will have minimal effect on ability
to drive or use machines. However,
please check with doctor if any
side effects may affect driving or
using machines.

How to use Duzen

How much to use

Apply to affected area 2-3 times daily, normally for 7 days.

When to use it

Please follow the advice of the doctor or pharmacist.

How long to use it

You should check with your doctor or pharmacist.

If you forget to use it

If forget to use this medicine, use it as soon as remember. Then next, use this medicine at the usual time.

If you use too much (overdose)
If used too much Duzen, contact your doctor, an emergency department or a poisoning center immediately.

While you are using Duzen

Things you must do Inform doctor of medications taking.

Things you must not do
Do not stop using medication although
feeling better after a few days, until the
prescribed course is finished.

Things to be careful of
If pregnant or become pregnant or
breast-feeding during treatment, should
not use *Duzen* unless doctor advised.

Side effects

Occasional occurrences of hypersensitivity reactions e.g. rashes and irritation. It may also lead to problems of resistance. If any of the side effects become serious or any other side effects not listed in this leaflet, please inform the doctor or pharmacist. Storage

Store in cool, dry place below 30°C. Protect from light. Keep out of reach of children. *Disposal*
