This leaflet answers some common questions about ELLGY CORNS & WARTS. It does not contain all the available information. It does not take the place of talking to your pharmacist or doctor.

All medicines have risks and benefits. Your pharmacist or doctor has weighed the risks of you taking ELLGY CORNS & WARTS against the benefits they expect it will have for you.

If you have any concerns about taking this medicine, ask your pharmacist or doctor.

Keep this leaflet with the medicine. You may need to read it again.

What ELLGY CORNS & WARTS is used for

ELLGY CORNS & WARTS is used to treat corns, warts and calluses.

How ELLGY CORNS & WARTS works

ELLGY CORN & WARTS contains the active ingredients Salicylic Acid.

Every bottle contains 17% w/v of Salicylic Acid.

Salicylic Acid is a keratolytic, by softening keratin, a protein that forms part of the skin structure. This helps to loosen dry scaly skin making it easier to remove.

Ask your pharmacist or doctor if you have any questions about this medicine.

Before you use ELLGY CORNS & WARTS

-When you must not use it

Do not use ELLGY CORNS & **WARTS:**

• If you are allergic to Salicylic Acid; or if you have any other allergies. This product may contain inactive ingredients, which can cause allergic reactions or other problems.

-Before you start to use it

Tell your pharmacist or doctor:

• If you have certain medical conditions. Before using this medicine, consult your doctor or pharmacist if you have: diabetes, poor blood circulation (e.g., peripheral vascular disease), skin infection irritation.

Pregnancy and breast feeding:

- Safe use during pregnancy and lactation has not been established.
- Ask your doctor or pharmacist for advice before taking this medicine if you are pregnant or breastfeeding.

-Taking other medicines

Tell your pharmacist or doctor if you are taking any other products (such as over the counter drug, and prescribed drug herbal products).

How to use ELLGY CORNS & WARTS

-How much to use

Apply a thin film of the ELLGY CORNS & WARTS directly to the affected area using the plastic applicator from the bottle.

Continue treatment twice daily with ELLGY CORNS & WARTS until the corn/wart/callus has completely cleared and the ridge lines of the skin have been treated.

-When to use it

When corns or warts appear. Make sure the affected area is clean and dry before applying.

-How long to use it

There is no immediate cure. The usual treatment time is 6 to 12 Persistence with the weeks. treatment and patience is essential.

-If you forget to use it

Apply the medication as soon as possible and then continue the rest of your treatment as usual.

-If you use too much (overdose)

information is available concerning over dosage in human beings following topical application.

While you are using ELLGY **CORNS & WARTS**

-Things you must do to

To achieve best results:

Step 1:

Soak the corn/wart/callus in warm water for 5 minutes, and then dry the area with your own towel.

Step 2:

Using 1 pumice stone or manicure emery board, carefully rub along the surface of the corn/wart/callus.

Step 3:

Apply a thin film of ELLGY CORNS & WARTS directly to the affected area using the plastic applicator from the bottle. Avoid applying to the surrounding normal skin.

Step 4:

Allow ELLGY CORNS & WARTS to dry and cover with a plaster.

-Things you must not do

Do not use if you are known hypersensitive to Salicylic Acid or any of the ingredients.

If any irritation develops then stop using the ELLGY CORNS & WARTS and wait for the irritation to go away, then recommence as above. If it does not get better within 48 hours or if it is getting worse seek medical attention.

-Things to be careful of

Do not use if you are diabetic or have impaired circulation unless under a doctor's supervision or recommendation.

Do not treat corn/wart/callus over large areas at one time.

Do not use on moles, birthmarks or unusual skin growths or, near eyes or on mucus membranes.

Avoid contact with eyes. If ELLGY CORNS & WARTS gets in the eyes or mucous membranes then flush immediately with water for at least 15 minutes and call your medical doctor.

Side effects

ELLGY CORNS & WARTS may have unwanted side effects in some people. All medicines can have side effects. Sometimes they are serious, most of the time they are not.

Salicylic Acid preparation may cause dermatitis.

Stop using this medication and tell your doctor immediately if serious side effects occur.

Storage and Disposal of ELLGY CORNS & WARTS

<u>-Storage</u>

Store in a dry place below 30°C. Keep out of reach of children.

-Disposal

Dispose the medicine after the expiry date.

Consult your pharmacist on how to safely dispose of any medicines no longer required.
