WHAT NIXODERM OINTMENT IS USED FOR

Externally caused pimples, blackheads, itching, rashes, ringworm of skin and scalp.

HOW NIXODERM OINTMENT WORKS

Nixoderm ointment is a firm ointment that adheres to the skin. It is formulated to keep its active ingredients in contact with the skin for the maximum amount of time. This gives better results than liquids or thin, greasy applications that quickly run off.

Benzoic acid provides good anti-fungal properties.

Salicylic acid is a keratolytic agent which treats and prevents acne.

Precipitated sulphur is a mild anti-septic, anti-fungal and parasiticidal agent.

BEFORE YOU USE NIXODERM OINTMENT

When you must not use it

This product should not be used by individuals with known sensitivity to any ingredients of this product.

Before you start to use it

If a person has extremely sensitive skin, Nixoderm ointment may cause some slight smarting. It will be wise to apply a thin layer of petroleum jelly over the affected areas, before applying Nixoderm ointment.

Taking other medications

Currently there have been no reports of problems when this product is used with other medicines.

HOW TO USE NIXODERM OINTMENT

<u>Treatment for eczema,</u> <u>pimples and rashes</u>

After cleansing, apply gently but thoroughly a liberal amount of Nixoderm ointment so that the entire surface is covered. This should be done twice daily, in the morning and evening. The treatment should be followed for seven days then discontinued for three days and resumed for further seven days. Continue this pattern of treatment until the condition has cleared up.

Treatment for foot itch

Clean and dry your feet thoroughly. Apply liberal amount of Nixoderm ointment onto the affected area, paying special attention to areas between the toes. This should be done twice daily, in the morning and evening. The treatment should be followed for seven days then discontinued for three days and resumed for further seven days. Continue this pattern until condition has cleared up. This is one of the most stubborn skin conditions, hence symptoms may disappear only to re-emerge. Therefore, it is recommended that treatment continue for three weeks after symptoms have disappeared.

Treatment for ringworm

Apply liberal amount of Nixoderm ointment twice daily, in the morning and evening. The treatment should be followed for seven days then discontinued for three days and resumed for further seven days. Continue this pattern until condition has cleared up. This is one of the most stubborn skin conditions, therefore it is recommended that treatment continue as long as it is necessary.

WHILE YOU ARE USING IT

Things to be careful of

Avoid contact with eyes. If any irritation occurs, discontinue use.

Storage

Store at 25°C in airtight container. Protect from light. Keep out of reach of children.

Disposal

Nixoderm ointment should not be disposed of via wastewater or household waste. Ask your pharmacist how to dispose of Nixoderm ointment no longer required. These measures will help to protect the environment.

What it looks like

Nixoderm ointment is a very light yellow, opaque, homogenous unctuous mass having a faint odour of menthol. It is available in a green, round can of 5.34gm and 17.7gm.

Ingredients

Active ingredients include: Benzoic acid, Salicylic acid, Precipitated sulphur.

Inactive ingredients include: Hard paraffin, Liquid paraffin, White soft paraffin, Titanium dioxide, Kaolin, Menthol.
