# What Axcel Skin Shield Cream is used for

Axcel Skin Shield Cream is used in the treatment and prevention of dry, scaly and itchy skin condition such as:

- Contact irritant dermatitis.
- Infantile eczemas.
- Allergic eczemas.
- Itchyosis.
- Hyperkeratotic.
- Winter itch in aged individuals.
- Winter chapping.

#### How Axcel Skin Shield works

Urea is a natural substance found in healthy skin. The presence of urea in this cream moisturizes and softening of the skin.

Vitamin E is a highly antioxidant. It helps to maintain healthy skin.

D-Panthenol improves hydration, reduce itching and inflammation of the skin and improves healing of wounds.

### Before you use Axcel Skin Shield Cream

#### -When you must not use it

Do not use Axcel Skin Shield Cream if:

- You are allergic or hypersensitive to the ingredients.
- You are pregnant, trying to get pregnant or think you may be pregnant.
- You are breast-feeding. Ask your doctor or pharmacist for

advice before taking any medicine.

## -Before you start to use it

Tell your doctor if:

• You are allergic to any medicines, food and dyes.

#### -Taking other medicines

Tell your doctor if you are taking any other medicines, including any that you buy without a prescription from a pharmacy, supermarket or health food shop.

It may still be all right for you to use Skin Shield Cream and your doctor will be able to decide what is suitable for you.

# How to use Axcel Skin Shield Cream

-How much to use

Direction for Use:

For external use only.

Apply sparingly and rub into the affected area.

#### <u>-When to use it</u>

To be used 2-3 times a day or when required.

Your doctor will decide when it is appropriate for you to use Axcel Skin Shield Cream according to the type of condition you have.

#### -How long to use it

Continue taking Axcel Skin Shield Cream for as long as doctor recommends.

### -If you forget to use it

Consult your doctor or pharmacist on what you should do if you forget to use it.

Take the missed dose as soon as you remember. If it is almost time for your next dose, wait until then to take the medicine and skip the missed dose. Do not take a double dose to make up for the missed dose.

#### -If you use too much (overdose)

Contact your doctor immediately or go to the Emergency Department of your nearest hospital, if you think you or anyone else may have taken too much of this medicine. Do this even if there are no signs of discomfort or poisoning. You may need urgent medical attention.

## While you are using it

#### -Things you must do

- Take your medicine exactly as your doctor has told you.
- Tell all the doctors, dentists and pharmacists treating you that you are taking Axcel Skin Shield Cream.
- Tell your doctor immediately if you become pregnant while talking this medication.

#### -Things you must not do

- Do not stop taking the medicine unless advised by your doctor.
- Do not take any new medicines without consulting your doctor or pharmacist.
- Do not give Axcel Skin Shield Cream to anyone else, even if they have the same symptoms or condition as you.

#### -Things to be careful of

- The product should not be taken orally.
- Avoid application to inflamed skin or exudative lesion.

### Side effects

Like all medicines, Axcel Skin Shield Cream can cause side effects although not everybody gets them. You are advised to consult doctor/pharmacist for further information. The following side effects have been reported:

• Stinging and burning sensation.

## Storage and disposal of Axcel Skin Shield Cream

#### -Storage

Keep Axcel Skin Shield Cream out of reach of children.

## AXCEL SKIN SHIELD CREAM

Urea / Vitamin E / D-panthenol (10% w/w / 2% w/w / 1.2% w/w)

Store below 25°C. Keep container well closed. Protect from light.

#### -Disposal

Do not use Axcel Skin Shield Cream after the expiry date which is stated on the carton.

Medicines should not be disposed of via wastewater or household waste. Ask your pharmacist how to dispose of medicines no longer required. These measures will help to protect the environment.
