What Otek-P ear drops is used for

Otek-P ear drops is used to treat ear related problems such as persistent discharge from ear, continuous bacterial infections of the ear, inflammation or infection of ear canal and also post-operative treatment for the ear.

How Otek-P ear drops works

Otek-P ear drops have antibacterial and antifungal activity which reduces inflammation and swelling and thus relives the significant symptoms of ear infection. Following topical application, Otek-P ear drops reduces swelling and itching. Otek-P ear drops is effective against bacteria that commonly infect the ear. Otek-P ear drops act topically and is suitable for individuals with ruptured ear drums or tubes.

Before you use Otek-P ear drops

- When you must not use it

Do not take Otek-P ear drops if:

- You are hypersensitive to any ingredient in the preparation.
- Before you start use it

Tell your pharmacist or doctor if you are using any other ear drops.

Pregnancy and lactation

Ask your doctor or pharmacist for advice before taking this medicine if you are pregnant or breast-feeding.

- Taking other medicines

Tell your pharmacist or doctor if you have recently taken any other medicines, including medicines obtained without prescription.

How to use Otek-P ear drops

This medicine is to be used in the ear only.

- How much to use

For Adults, childrens & elderly:

Instill 4 to 5 drops in affected ear three to four times a day after meal.

Keep using Otek-P ear drops as instructed by your doctor.

- When to use it

Always use Otek-P ear drops exactly as your doctor has instructed you. You should check with your doctor or pharmacist if you are unsure.

- How long to use it

Consult with your doctor or pharmacist for the treatment period.

- If you forget to use it

If you forget a dose, put some in as soon as you remember. However, if it is nearly time for the next dose, skip the missed dose. Do not use a double dose to make up for a forgotten dose.

- If you use too much (overdose)

Otek-P ear drops is for external use only. Do not worry if you use too much Otek-P ear drops. Simply wipe away any surplus running from the ear with a tissue. No symptoms of overdose reported.

While you are using it

- Things you must do

If you are about to start taking on any other new medicine, tell your pharmacist or doctor that you are taking Otek-P ear drops.

Always put the cap back on the bottle as soon as you have used it

Things you must not do

Do not take more than the recommended dose unless your doctor tells you to. Do not use after the expiry date shown on the bottle and the carton. The expiry date refers to the last day of that month.

- Things to be careful of

Discontinue use if irritation or symptoms of sensitivity reaction develops.

Side effects

Like all medicines, Otek-P ear drops can cause side effects although not everybody gets them. Tell your doctor immediately if you experience the following symptoms after taking this medicine as the symptoms can be severe:

• Hearing loss upon prolonged use.

Storage and Disposal of Otek-P ear drops

- Storage

Store below 30°C in a cool, dry place.

- <u>Disposal</u>

Medicines should not be disposed of via wastewater or household waste. Ask your pharmacist how to dispose of medicines no longer required. These measures will help to protect the environment.
