## What Dyna Inhaler is used for

Indicated for the symptomatic relief of nose blocked due to cold, flu, hay fever.

## How Dyna Inhaler works

Camphor, Menthol and Eucalyptus Oil dilate the vessels, stimulate cold receptors causing a sensation of coldness in the nose.

## Before you use Dyna Inhaler

### - When you must not use it

Do not use Dyna Inhaler in infants under 2 years of age.

### Pregnancy and Lactation

Ask your doctor or pharmacists for advice before taking Dyna Inhaler.

### - Before you start to use it

Tell your doctor if you are hypersensitive to the ingredients of the preparations.

### - Taking other medicines

Tell your doctor if you are taking any other medicines, including any that you buy without a prescription from a pharmacy, supermarket or health food shop.

## How to use Dyna Inhaler

### - How much to use

Use as often as needed. Insert into each nostril and inhale deeply.

The directions given may differ from the information contained in this leaflet. If you do not understand the instructions on the label, ask your doctor or pharmacist for help.

### - When to use it

Use as directed by your doctor or pharmacist.

### - How long to use it

Continue taking Dyna Inhaler for as long as your doctor recommends.

### - If you forget to use it

Take the missed dose as soon as you remember. If it almost time for your next dose, wait until then to take the medicine and skip the missed dose. Do not take a double dose to make up for the missed dose.

### - If you use too much (overdose)

No reports regarding overdose.

Contact your doctor immediately or go to the Emergency Department of your nearest hospital, if you think you or anyone else may have taken too much of this medicine. Do this even if there are no signs of discomfort or poisoning. You may need urgent medical attention.

## While you are using it

### - Things you must do

Take your medicine exactly as your doctor has told you.

Tell the doctor, dentist and pharmacist treating you that you are taking Dyna Inhaler.

### - Things you must not do

Do not take any new medicines without consulting your doctor or pharmacist.

Do not give Dyna Inhaler to anyone else, even if they have the same symptoms or condition as you.

### - Things to be careful of

Caution must be exercised when older children are treated. Do not place any camphor-containing product into the nostril of children. A small amount applied this way may cause immediate collapse. Avoid direct application into the nostrils.

## Side effects

Menthol may give rise to hypersensitivity reactions including skin inflammation.

Visit your doctor or pharmacist immediately if you experience any side effects after taking this medicine. You may report any side effects or adverse drug reactions directly to the National

## Storage and Disposal of Dyna Inhaler

### - Storage

Keep out of reach of children  
Protect from light  
Store in dry place below 30°C

### - Disposal

Medicines should not be disposed of via wastewater or household waste. Ask your pharmacist how to dispose of medicines no longer required. These measures will help to protect the environment.
